The FairTax – H.R. 25 will ...

- ▶ Repeal the current withholding & payroll, corporate & self employment, gift & estate taxes for ALL
- ▶ Repeal the 65,000+ page Income tax code & disband the IRS at a \$250 billion compliance savings for ALL
- ▶ Allow you to keep 100% of your paycheck (after state & local deductions) to spend or save as YOU choose
